Thunderbird Trust Housing Repair Program offers financial assistance to homeowners for home repairs that will preserve the quality of housing for both On and Off Reserve members.

APPLICATION DEADLINE: JUNE 27, 2025

Who Can Apply? COTTFN Members who own a home (per eligibility requirements).

Eligible Properties: Residence must be principal of applicant(s) & minimum 5 yrs old

Eligible Repairs:



Non-Eligible Expenses

- Wage for homeowner/ resident to complete work
- Cosmetics repairs (patios, fireplaces, gazebo, etc.)
- Any repairs carried out before written loan approval from Thunderbird Trust

Financial Assistance: A forgivable loan up to <u>\$5000.00 (CAN)</u> per home/owner.

Required Documents: The following documents are required.

- 1. Proof of membership copy of status card
- 2. Proof of home ownership with applicant's name copy of mortgage
- 3. Pictures of area needing repairs

Criteria: Must provide all required documents and did not receive funding last round.

Selection process – A random blind draw once applications are verified eligible.

This fund will be split between ON and OFF Reserve members and drawn randomly.
